Advocating for Our Members: Co-op Leaders Engage with Legislators in Raleigh and Washington, D.C.

At Edgecombe-Martin County EMC, our top priority is serving our members with safe, reliable, and affordable electricity. That's why we actively engage with policymakers at both the state and national levels to advocate for policies that support our mission.

Last month, we joined representatives from all 26 of North Carolina's electric cooperatives at the annual Rally in Raleigh, where we met with state senators and representatives. These conversations focused on key issues impacting our members, including energy reliability, affordability, and innovative solutions for the future.

Our advocacy efforts don't stop at the state level. Later this month, we will travel to Washington, D.C., to participate in the National Rural Electric Cooperative Association's (NRECA) Legislative Conference. Statement of Non-discrimination



April Rights-of-Way

In order to provide safe, affordable, and reliable electrical service, we maintain the rights-of-way under and around our power lines. Maintaining

these rights-of-way is critical to prevent vegetation from interrupting service. Our vegetation management efforts include pruning, brush cutting, and removing trees and other growth that could pose a risk to the system. These proactive measures help us minimize outages and improve overall reliability for our members.

Throughout April, Burford's Tree will utilize the sky trim, buckets and bushhogging equipment, in the Princeville area, Highway 111, Roberson school road, and various hotspots on the system.
